STEPS: Before and During The Demolition

	THE BUILDING	
	Stay inside during demolition and while debris is being removed from the site.	Children should not be outside during demolition or play in areas of bare dirt at any time.
	Make sure that your windows and doors are closed. If extremely necessary, use doors or windows that face away from the demolition site. Clean all pets, toys, and tools and bring them inside.	Remove shoes at the door, and check clothes and shoes for dust before entering the home. Wash hands before eating, especially after playing or working outside.
	Cover garden plots with plastic sheeting & throw away the sheeting after demolition.	Wash children's toys, especially those that may enter their mouth.
	STEPS: After The	Demolition
	Clean exterior windows and window surrounds with paper towels and throw them away after the demolition.	Clean floors and other surfaces where dust collects with warm, soapy water and paper towels, be sure to throw it away.
	Use two buckets — one for dirty rinse water and one for clean soapy water, and change water frequently.	After you mop your house, mop your porches. Do not use water you use on your porch inside your home.
	Do not touch or remove any debris near the demolition site.	Check with your family doctor or a professional to discuss testing your child for lead.
Please Call 330-979-6859 If You See:		
[Demolition or debris removal spray or mist.	
Open holes or debris piles with easy access or without plastic fencing.		
Flooding or soil runoff onto nearby properties.		
[Anyone dumping garbage or debris at the property.	
Any other demolition practices that are concerning to you.		
Demolition waste that stays behind for more than 5 days.		

Open holes from basement removal that are not filled for more than 72 hours.
